Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

A single white poplar tree 15 yards south of the oak tree marked on Plan A at location A in PP-11537760 dated 9th September 2022.

Tree evidently had a second major trunk felled under previous ownership. Remaining trunk has successively lost several major upper boughs to gales. Periodic profusion of fungus in lower 4 feet of trunk infers presence of rot and weakness with scope to become unsafe to people and livestock.

Proposed works - make safe on one or more occasion by part removal of boughs and/or trunk above about 15 feet and/or by felling. Note that for more than 5 years, wild/feral bees have been present in a cavity in the trunk at about 12 feet from the ground. For this reason consideration will be given to avoiding felling the tree in its entirety.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
