T1 Oak tree at front of property, carry our a height reduction of approx. 3-4 meters leaving overall height of 12-13 meters., reducing the width by approx. 3-4 meters leaving an overall width of 10-11 meters.  To also carry out crown maintenance removing all major dead wood and rubbing branches.
