Fir tree that has 5 trunks. The tree is extremely tall and moves considerably in high winds, there is bark coming away at the base and a hole in the trunk forming. With the height of the tree, if it comes down in high winds towards Fountain Road, it is tall enough to fall into the road. I want to cut it down completely and put hedging where it was and also add a few more fruit trees in the garden.

Also the tree has lost quite a few branches and had a lot of brown leaves during the summer, so I don't think it's particularly healthy.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
