T157 - Sorbus x thuringiaca (Bastard Service Tree):

FLG - Fell ground level - (and grind stump following tree removal) moribund sorbus to prevent failure onto garden footpath and public road.

PNT - Plant replacement tree - Betula albosinensis 'Red Panda' in the first planting season following tree and stump removal.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
