T10 Scots pine—Pinus sylvestris height 26m- a bracket of the decay causing polypore Phaeolus schweinitzii at the base of the south side of the trunk (see photo). Large branch failure (see photos) at 9m with damage to roof on 02/01/2024. 9 degree lean towards house.

Co-dominant stem, trunk bifurcates at 9m, open union structure. E stem longitudinal column of dysfunctional bark running from 9.5-11m S side, corresponding reactive rib from 9.5-10m N side, possible occluded hazard beam crack. Historical branch failure at 16m. Minor dead branches throughout crown.

High damage/safety risk if tree fails/falls.T10 Propose fell to ground level as safety measure.

History adjacent/surrounding trees

T9 Adjacent tree snapped in recent storm 02/01/2024 (see photos) possible Phaeolus schweinitzii

T8 removed because of Phaeolus schweinitzii bracket observed PLAN/2021/1271.
