- G2 Mixed Broadleaves Clean Out Deadwood and dead stems over paths and Straight Fell (x 35 marked trees) Fell poor specimen trees adjacent footpath.
- T2 Common Lime Crown Lift to Clear Street Light and rest of skirt to 2.4m

#### **Gynsills Nature Park**

- T48 Common Lime Clean Out Remove dead wood over 2" in diameter.
- T51 Austrian Pine Clean Out Remove large deadwood lowest 3 limbs
- T52 Sycamore Section Fell
- · T56 Common Walnut Section Fell Trunk leaning over path
- T58 Crack Willow Section Fell
- T29.5 Crack Willow Re-pollard
- T30 Norway Maple Re-pollard
- T18 Ash Crown clean
- T1 Common Walnut Raise crown over highway
