Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

STRIP of land opposite the house approx. 40m in length (moving from the garage block towards the brick pillar). This work focusses on clearing the undergrowth and improving sight-lines for road users/pedestrians and is detailed below ;

T1 *Fagus sylvatica* - common beech:

Mature roadside tree;

Remove back to the main stem the small branch growing into the carriageway

T2 *Tilia x Europaea* - common lime:

Mature roadside tree;

Remove the large epicormic growth growing over the road and any smaller associated epicormic growth

T3 *Fagus sylvatica* - common beech:

Young roadside tree;

-Prune to KCC highways spec. (clearing road of growth)

T4 *Tilia x Europaea* - common lime:

Mature roadside tree;

-Remove epicormic growth

T5 *Fagus sylvatica* - common beech:

Young, heavily leaning roadside tree;

-Fell to ground level

T6 *Tilia x Europaea* - common lime:

Mature roadside tree;

-Remove epicormic growth

R/H/S BOUNDARY (viewed from the road)

T7 *Quercus ilex* - Holm oak:

Early maybe, multi-stemmed tree located on the boundary, behind the garage. This tree has caused damage to the garage and it appears the boundary wall also, where movement cracks are visible (photos can be provided);

-fell to ground level.

T8 NEIGHBOUR'S TREE R/H/S boundary (viewed from the road)

Fraxinus excelsior - common ash:

Large tree located in the neighbouring garden with one over-extended limb growing over the boundary, garage and house by 8m approx.

There pruning cuts in the crown where other extended branches that have recently failed;

- Reduce the large limb back to the boundary. From 8m in length to 2m (boundary line)

G1 *Acer pseudoplatanus* - sycamore:

Three mature, ivy bound trees located along the alley and side of the house;

-Crown-lift to 5-6m AGL (above ground level)

-Prune to give 3m clearance from the fabric of the building to stop furthest interference with the fabric of the property.

G2 Not clear if this is in the TPO schedule

REAR GARDEN

Cupressocyparis leylandii - Leyland cypress:

Two large trees located on the r/h/s boundary;

-LIFT the crown of the tree furthest from the house by removing the branch that grows over the garden at 2.4m AGL

-CONTINUE this new height across to the other conifer

T10 *Taxus bacata* - common yew:

Located on the r/h/s boundary;

-LIFT the crown to the same height as the conifers - 3m AGL

T12 *Salix babylonica* - weeping willow (exempt works but in the interest of transparency):

Ivy covered tree located towards the rear boundary on the r/h/s:

-REMOVE the deadwood on the branch growing over the garden

-It is recommended that the ivy be stripped from the crown of this tree

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

e.g. Oak (T3) – Whole crown reduction to 12m above ground level, to provide sufficient clearance to property.

Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
