T1 - Oak - Reduce canopy by approx. 30%. To achieve this we would remove 2-3 metres from the Southern side of the canopy, over the track behind

1-2 Metres from the Northern side, garden side. This would leave the tree at a final height of Approx. 8-9 metres and a lateral spread of approx.6 metres.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
