Solar Panels are a modern addition to a building and as such, solar panels on the roof of Grade II listed Crooks Hall could cause harm to the listed building, by being visually unattractive, and would not be supported by the Conservation Officer. They are not considered to contribute towards the preservation of the building. Solar panels elsewhere on the site could be acceptable, subject to them not being on an elevation which would be seen in context with the principal elevation of the listed building, and not being visually prominent on the site. It would be favoured that the solar panels would be matte and flush with the roof tiles to be less visually dominant.
