The trees I planted 15-20 years ago. There are x5 Leylandii and x1 Norway spruce (Christmas tree planted circa 30 years ago).
The trees were planted to create an element of privacy, particularly from the canal footpath. They are now very large and have no visual protection on the lower branches. They trees also are so tall they are worrying the neighbors in high winds.
The trees will felled and replaced.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
