Four oak trees over hanging the pavement and and the road in Handford Lane need attention during recent high winds several significant branches have fallen in the road and in our garden (approx 1m in length) We moved into the property almost two years ago no work has be carried out on the trees for approx 12 years confirmed by the previous owners. I have included quote from Oct 2022 for the scope of work along with a location of the trees.

Please note high vehicles including busses and lorries occasionally bring down bring down small branches .

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
