## Identification of Tree(s) and Description of Works Please identify the tree(s) and provide a full and clear specification of the works you want to carry out Four hornbeams located on the map of TPO.TVBC.290.pdf. Details of Proposed Works: Tree Identification: The trees subject to maintenance are Hornbeams, labelled as Tree 1, Tree 2, Tree 3, and Tree 4 in the attached sketch plan. These trees are recognized for their ecological and aesthetic value in the area. Purpose of Maintenance: The primary reasons for undertaking this maintenance work are: Regular upkeep to ensure the vitality and structural integrity of the trees. Removal of dead and decaying branches to prevent potential hazards, promote healthy growth, and maintain the trees' aesthetic appeal. Scope of Work: Deadwooding, crown lifting to four meters, keeping pruning wounds to 40mm. Work Methodology: All maintenance work will be carried out by certified arborists, employing best practices to ensure the well-being of the trees and the safety of the surrounding area. Care will be taken to minimize disturbance to the surrounding environment and ensure that no damage occurs to the property or neighbouring flora. Assurance of No Felling: It is explicitly stated that no felling of trees will occur during this maintenance. The work is strictly confined to the pruning and care of the existing Hornbeam trees. Reference to Sketch Plan: A detailed sketch plan accompanies this application, illustrating the location and numbering (1 to 4) of the Hornbeam trees within the site. This plan serves to provide clear visual guidance for the maintenance activities. You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work. Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements). Please provide the following information: Tree species

- The number used on the sketch plan; and
- A description of the proposed works.

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - mark and name surrounding roads
  - o sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
