Please see the attached aerial photograph, the yellow box indicates Quaker Farm. The two orange stickers numbers 1 & 2 are the trees in question.

- 1. A mature ash tree which has lost limbs over the years to storms. We are applying to reduce this tree right around maintaining a good shape and preventing the loss of further limbs. The tree is approximately 10.25m high and 11.5m wide. This work would see the tree reduce down to 9m and the width, (predominately two of the lowest laterals) reduced to 10m wide (depending on growing points). Maintaining a good shape right around.
- 2. This section of hedge is made up of overgrown leylandii and ash saplings which has previously been topped many years ago. The proposed work would see this hedge line reduce from heights varying from 3-7.5m taken down to 2.5m. Creating a manageable hedge which can be maintained.
