Identification of Tree(s) and Description of Works

I wish to remove the Common Ash tree located in the far corner of my property, as its presence affects both the rear gardens of my neighbours at 35 and 33 Pawson Street. Their west-facing gardens are impacted, with the tree situated directly to the west which means they have light blacked by their houses in teh morning and then by the tree in the evening.

I intend to replace the Common Ash with a smaller fruit-bearing tree, preferably an apple tree for its blossoms. Although I had received approval to take down the previous tree that was already dead, unforeseen major surgery following a road traffic accident meant I had not achieved and it came down in the recent storms causing damage.. Observing the significant light gain and being cautious about potential damage caused by a large tree to the rear area is the driving force behind this removal request.

The tree in question is marked as Number 1 on the sketch.

It removal will be lobbed at the top branches first to make it a reasonable safe to then take the main trunk down in a controlled manner.

Tree is marked as 1 on sketch tree_mark_to_be_felled_1 and circled in red on google_map_tree_location.png

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
