T1 - Tilia sp Crow lift to remove growth below the horizonal of all pollard points to establish a higher canopy and reduce shading. In the summer of 2025 the process of lifting is to be repeated, and the remaining crown is thinned by 25% to allow select regrowth to establish.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
