#### T1 - Ash

Suggested Works: Reduce eastern canopy away from No. 2 by 2 metres, Maximum Diameter of Cuts (MDC) 40mm.

#### G2 - Ash & Field Maple

Suggested Works: Crown reduce both trees by 2 metres, reducing away from garage roof. Reduce eastern aspect to contain and reduce dominance over neighbouring property.

All aspects of the works are considered appropriate management of the trees.

The works to T1 will have a limited impact on the tree's physiological processes and prudent to lightly prune the tree now rather than a heavier prune in years to come.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).

- if there are many trees on the site, make clear which tree(s) are included in this application by:

  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
