T1- Eucalyptus globulus (Tasmanian blue gum) Rear boundary-

- Climb to reduce in height by approximately 3m, from 18m down to 15m and average radial spread by approximately 1.5m from 5m to 3.5m.
- Remove to source over extended limb over the clients shed/patio area back to source.
- Remove major deadwood.
