G1 - Laurel Hedge. Suggest crown raising lateral growth off the wall and part of the pavement to achieve better access for pedestrians.
T1 - Mature Yew. Suggest selective crown reduction. Focussing on lateral growth extending into garden. Suggest cut back around 1-1.5 metres. Working to BS3998, all reduction work will be to favour the overall health and structure of tree.
T2 - Mature Leylandii. Previously topped. Remove secondary stem that is growing over and into neighbouring property (highlighted in photo). Retain main stem of the tree.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
