The tree is a conifer growing within a large established hedge. Growth of this tree has been significantly impacted by a tree that was felled at 5 Stoke Hill a couple of years ago and has failed to recover.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
