This application is a follow on from that made in 2015, submitted on 28th August 2015, and subsequently approved, and which followed on from the discussions; advice from and subsequent agreement with Wyre Forest DC's Arboriculturist at the time (Alvan Kingston). The work was considered necessary due to the fact that the two trees are very close together and are competing for nourishment; light and room to grow. This, coupled with the size and very close proximity of the two trees to our house, together with the fact that our garden is relatively small and the trees are once again severely restricting natural light into our house.

The trees have now grown beyond the level and extent to that which existed in 2015 and therefore further equivalent (to that previously agreed by the Planning Authority) trimming work is now necessary in order to return the trees to their 2015 size and appearance.

Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

The trees T1 (English Yew - tag no. 1108) and T2 (Scots Pine - tag no. 1109) are identified on the previously submitted sketch plan, which is now attached, and both fall within the area of land marked W1 on T.P.O. no. 1997.

The work can be summarised as follows:-

1. Tree 1 - English Yew:-

- i) Crown reduction up to 1.5m max.;
- ii) Max 15% - 20% thinning;
- iii) Remove dead branches from the canopy, and
- iv) Sever Ivy from the base and remove from the canopy.

2. Tree 2 - Scots Pine (Immediately behind / adjacent to Tree 1):-

- i) Crown reduction up to 1.5m max;
- ii) Max 15%- 20% thinning;
- iii) Remove dead branches from the canopy, and
- iii) Remove Ivy from the canopy, as 1iv) above.

Note :- A crown lift is not required in either case.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
