Erection of two garden rooms:

"The plans for the proposed two garden rooms have been reviewed, which shows a horizontal boarded timber structure with a shallow pitch roof and UPVC windows and doors. Whilst, it is likely that one could be accommodated from a conservation perspective, further information in the form of a block plan and materials, would need to be submitted to assess the impact on the setting of the listed building of two.

Consideration will need to be given to the location, orientation of the buildings and their overall massing."

I can confirm that whilst Listed Building Consent will not be required for the garage, as specified in Class E, Part 1, Schedule 2 of the Town and Country Planning (General Permitted Development)(England) Order 2015, given that the outbuilding will be sited in the grounds of a Listed Building, planning permission will be required."
