T1 Lime Tree: Remove lowest limb back to the main stem approx. 4m limb illustrated back to primary trunk, to maximise light penetration to understory plants and improve overall shape.

Reasoning - overweighed limb casting understory planting in too much shade.

All work to be carried out in accordance with British Standards 3998 2010 "Recommendations for Tree Work"

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
