The tree is "T1" and the report includes its location (appendix 1, page 15) and Tree Surgery Advised (appendix 3, page 17). See also 4 images taken on 21 January 2024. My request is for Crown lift to 4.5m, in line with previously completed works i.e. to deal with episodic growth. All works to accord with BS3998 Tree Works and to be carried out by my usual Tree Surgeon (Beechwood Tree Care). The reasons for

the request are that, especially when the tree is in foliage, this and the epicormic growth significantly shades a portion of my rear garden - specifically the vegetable patch (located there from before I moved to this house in 2006), and a boundary conifer which screens my house/adjoining neighbour. The lower branches now extend to the vegetable patch, only 2-2m from the side of my house and roof. See attached images showing how part of the boundary conifer is dying due to shading by T1, and the encroachment to the side of my house. Images: A) part of dying conifer caused by shading from T1. B) Perspective showing T1 branches approaching my garage roof. C) T1 showing epicormic growth, white mark on trunk is approx 4m. D) T1 perspective showing epicormic growth and vegetable patch & side of house.
