We are going to commence the works involving bricks only for now, and I will forward pictures of the parapet and wall copings to follow - hope that is ok to allow us to make a start

In your particular case I think that you need to request :-

1. **"Discharge of condition 4 (brick samples) and 5 (parapet and wall copings) of planning permission PF/20/0756"** – Fee required £43- fee is per request, so can include several conditions.
2. **"Discharge of condition 4 (brick samples) and 5 (parapet and wall copings) of listed building consent LA/20/0757"** – No fee req'd

I attach a copy of the listed building consent **LA/20/0757** (which was required alongside the planning permission with similar conditions).

We will then set up the 2 applications.

Photos of the samples should be sufficient, but if applicable, please confirm the manufacturers, product name and colour.

The fee can be made by card ringing **01263 513811** quoting ref [REDACTED] **AFTER YOU'VE SENT** the email request.
