REASONS FOR PROPOSED WORKS

I ACQUIRED THE LAND IN QUESTION ON 25 JANUARY 2024. THE PREVIOUS OWNERS APPEAR TO HAVE NEGLECTED THE TREES OWING (I AM INFORMED) TO ILL HEALTH HOLLY STUMPS 1 AND 2 ARE SIMPLY UNSIGHTLY (I APPEARS TO BE DEAD), WHILE 3 AND 4 HAVE REACHED A CONSIDERABLE HEIGHT AND SPREAD AND THUS OVERSHADOW BOTH THIS GARDEN AS WELL AS THE NEIGHBOURING GARDEN TO THE REAR OF NOS. 49 AND 44. THE ENTIRE LENGTH OF BOUNDARY HEDGE (THE MAINTENANCE OF WHICH HAS BEEN CONFIRMED AS MY RESPONSIBILITY) IS ENTIRELY COMPOSED OF CONTIGUOUS HOLLIES AND THE PROPOSED WORK WILL REDUCE THE TREES BACK TO THE ORIGINAL HEDGE LINE. COPPING THE HAZEL (NO. 5) WILL EXTEND THE LIFE OF THE TREE AS WELL AS OBVIATING LIGHT LOSS TO THE GARDEN.
