Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

This is an application to fell 2 trees, a mulberry at T1 and a conifer at T2, in order to improve the quality of the landscape for the owner's benefit. Please see Topographic survey Job 3828/Drawing No. 01. T1 Mulberry - Fell. This is a tree primarily suited to parkland and has outgrown this garden. It is only 20 years old and has already become a very large tree. It is now out of proportion and dominating the whole of the southern end of the garden, affecting the owner's enjoyment of the space and blocking out a significant amount of light to this single storey house. It also sheds its fruit prolifically and the arising stains even find their way into the owner's house. Due to its size, it has become the 'wrong tree in the wrong place'. The new garden design recommends the planting of 8 new native trees (some of which will be fruiting and of sound wildlife value) which will be smaller, slower growing and more appropriate to the space. Please see Concept Design Drawing No. HW 2335/1 for the locations of the new proposed trees. T2 Conifer - Fell. This is a tall tree of low amenity value which is showing signs of disease. Please see photos 1 and 2. If you make a site visit, please feel free to contact me if you would like me to attend, as I live locally.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
