We had a tree survey (under BS5837:2012) carried out in January 2022 to assess the condition and health of the trees. This survey will be attached to this application.

## Identification of Tree(s) and Description of Works

#### T4 Common Beech / Fagus Sylvatica

We would like to remove this tree as it's previously been approved to be felled under application 54168/003. As per 54168/003 it's small and suppressed by its neighbouring trees and can only ever grow towards the house being a continuing issue. Our own survey (carried out under BS5837:2012) states it's condition for the crown and stem as 'poor' and basal area as 'fair'. It's age is

stated as semi-mature and it has a poor height to slenderness coefficient. This survey is attached to the application.

#### T3 Common Beech / Fagus Sylvatica

We would like to remove this tree for several reasons. The local council has been in contact verbally to discuss reducing the tree as it's overbearing their property (car sales business adjacent to the property). When viewing the tree from this property, it's overbearing and within close proximity to the property.

The tree is also overbearing our property, reducing natural light to both the property and the garden. We are increasingly concerned about the proximity of the tree to the house and subsequently the enjoyment and amenity of our property.

Our gutters are regularly overloaded, and have to be professionally cleaned out several times a year to ensure the down pipe does not overflow – potentially causing damage to brick work by allowing water to trickle down our brick walls, finding its way into the smallest cracks. Not only can this excess moisture damage our brick and mortar, but it can also cause interior damage.

Our own survey (carried out under BS5837:2012) states it's condition as 'fair' and its age as mature. The survey is attached to the application. This tree also leans over the boundary between our property and the councils property, meaning we are unable to erect a fence or suitable boundary between the properties. This is having an impact on the privacy and security at the front of our property.

We understand that if approved, the work should be in accordance with BS.3998 (2010) to ensure work of sufficiently high standard is carried out on protected trees.

As residents of the area (living on a no-through road, not frequently visited by the public), we like the natural beauty at the rear of the property, and there are several trees to the rear of the property, and running alongside Blendworth Church Centre. We do not believe these trees (in the middle of buildings) will have a significant impact on the beauty of the area. On the contrary, increasing the natural light to our garden will provide a better quality of light for plants and wildlife in our garden. There is no view of the trees while walking along the B2149.

Although planting additional trees would be beneficial, due to the number of large trees in the area, there is not sufficient space to allow more trees to be planted, and to thrive without being overcrowded by the significant number of existing trees.
