T1 Tag N/A English Oak Height 20m Crown Spread: 18m Age: Mature

Observations: Fruiting body of (*Pholiota squarrosa*) Shaggy Scalycap located at ground level to Southwest side on surface root. Stem cavity at 1.7m to West side with internal sapwood decay. Stem wound to East side at 2.5m with internal sapwood decay and (*Kretzschmaria deusta*) Brittle cinder located within the cavity, hollow sound when tapped to that areas to both the East and Southwest sides. Historic branch tear outs throughout the canopy. Crown deadwood present.

Recommendations:

Crown reduce by 3m all round in both height and lateral spread. height to be reduced to 17m and crown spread reduced to 15m

Tree works to BS3998 (2010) No pruning wounds to exceed 50mm in dia.

Carrying out the crown reduction to the tree will help to reduce the pressure on the lower section of the stem where the known cavities are located, including reducing the end loading of the lateral spread of the canopy.

T2 Tag N/A English Oak Height: 19m Crown Spread: 16m Age: Mature.

Observations: The fruiting bodies of (*Pseudoninotus dryadeus*) Eiffel Tower brackets located in multiple places within the buttresses to West, East and North sides old and fresh brackets in appearance. Hollow sound when tapped to those areas. Multiple pruning wounds on stems, Co-dominant stems at 6m. Crown deadwood present.

Recommendations:

Crown reduce by 3m all round in both height and lateral spread. Height to be reduced to 16m and Crown spread to be reduced to 13m Tree works to BS3998 (2010) No pruning wounds to exceed 50mm in dia.

Due to the fruiting bodies located at ground level, the crown reduction will help to limit the pressure to the tree roots and stem areas of the tree.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
