Regarding: Lime tree the subject of Tree Preservation Order No 1969/2

Re-pollard by 2metres to boundary on the two limbs closest to No.11 Thompson Close, to remove re-growth towards the property and maintain clearance to property.

This is a rolling consent once every 18 months for a period of 9 years.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
