We are submitting details of the stone blocks to be used in the building of the monument and details of the statue to be placed on the monument.

• In line with Condition 2, we are requesting your approval of the following items prior to the commencement of any above ground works,

o The material which we desire to use to create the vertical stone column with, please see photo number 1, 2, 3 and 4. In line with the application, the dimension of each block is 0.7m (d), 0.6m (w) and 0.3m (h). Details of the construction of the statue are also provided on drawing number MGM 001

o The statue to sit on top of the stone column, please see photos 5,6 and 7. We were unable to locate a metal statue of a World War 1 Soldier, the decision was taken to commission a statue to be made of a World War 1 nurse in remembrance of Alice Thomasson who is referenced in the planning submission and in the officers report, this will further enhance the area and the cultural importance of this particular remembrance memorial due to the poignancy of her being a resident of Moses gate and the only female from the area to die in active service. The dimension of the statue is 915mm (h), 508 mm (W) and 305mm (d)
