Details of the pre-application advice received

Having examined the proposal, I can confirm our opinion is that this does not need Building Regulations Consent. However, Planning Permission is required as it is considered that use of the property as a holiday let is likely to result in a material change of use from that of a residential dwelling (due to a prospectively high turnover of occupants, housekeeping/servicing following departure of guests etc and possible associated impacts of the use on neighbouring residents), being beyond the operations of an ordinary residential dwelling. Smaller properties (or those offering accommodation for limited numbers of guests) are less likely to cause significant issues for neighbouring residents, however an assessment of the impact of the change of use is still required by the Local Planning Authority.
