It's very disappointing that you won't register the LBC application without 1:20 cross sections of the windows when I've already agreed their replacement on a like for like basis with Shaun Norman. I am in the middle of getting a sample window delivered from David Urquhart of Portsoy, I can deliver this window to you and Shaun for approval and I'll happily draw up 1:20 sections when I've approval from yourselves.
