The property will be used as a residential children's home for up to 4 young people. The home will be staffed day and night by a team of staff. In terms of changes to the building, there will be no changes other than to ensure that it complies with fire regulations.

There will be a maximum of 3 staff on shift at a time (including a manager). Shift patterns are 7am - 2:30pm, 2pm - 11pm, and a sleep in shift of 11pm – 7:30am. Typically staff will complete multiple shifts in a row and will remain on shift for 24 hours. Shift changes are done so that only one member of staff is being replaced at the shift change to ensure the continuity of care throughout the day, which also reduced the movements to/from the home.

Typically 60% of our staff drive to work with some car sharing, 30% take public transport, and 10% walk, so we would likely have 1 or 2 staff members with cars on site. The site has parking for 6 cars on the drive.

Young people attend local schools wherever possible.

Young people typically do not receive visits from their family on site, and contact with family is at the family home.

Visits from social workers are usually on site and young people are visited by social workers typically once a month.

Any other comings/goings from the house would be very similar to a regular family home, e.g. food shopping, activities, etc.
