Two lime trees on the rear boundary of our property. Re-pollard to point where this has been done previously reducing height by circa 30-40%.

Sycamore on land immediately to rear of our property. Remove two branches overhanging our garden. Efforts have been made to identify owner of this land including via Parish Council but to no avail. Immediate neighbours have indicated they have no objection to this work.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
