Although beautiful, the Acer in our front garden has grown to more than 30ft tall and is less than 2 metres from the foundations of the bungalow. It is a large tree and

measures 51 inches circumference at the base, 42 inches in circumference further up. The roots have actually

reached the foundations and are lifting pavement slabs. If damage has not

yet been caused, it will happen very soon and this needs to be prevented. We are reluctantly asking permission to completely remove the tree to prevent damage which will undoubtedly be caused.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
