Description of Proposed Works

Please describe the proposed single-storey rear extension

A simple extension, measuring the width of the house minus 45cm (to allow walkway to continue down the side of the house). Existing shared passageway between us and 48 Morrell would not be infringed on, and the extension would continue the line of the existing covered section between the existing house and the outbuilding.

Brick exterior on south and east sides, rendered on west (not visible). A shed roof (cement tiles to match the rest of the house), maximum 380cm as it meets the house, sloping to approx. 300cm, with two vellum roof lights towards the existing house. South facing wall to include two French doors with top-lights, spanning approx. 1.8m each. Eaves extending an additional .5m for passive solar on the south side. The walkway that is shared between us and 48 Morrell would be extended on our side, so a pathway of approx. 95cm on our side of the property line would continue to the end of the extension.

This extension mirrors the one on the house at 44 Morrell, adjacent on the west side, and the roofline and size of the extension will be very close to identical.

This will involve removing our side of the shared outbuilding, ensuring that the half which belongs to 48 Morrell is untouched (and bolstered if necessary).
