Identification of Tree(s) and Description of Works

I have consulted a professional tree surgeon in respect of this application.
There are no TPOs on the two trees in question.

The two trees for proposed removal in this application are both c30m tall Corsican Pine, with significant dieback from ground level to canopy which starts at c20 high. Professional report identifies roots of one trees is destroying foul water drains of Adams Cottage due to root incursion. Professional drain report available with photos available on request. Concern exists the trees are now subject to strong winds from the SW, and due to their height, are more likely to fall and cause damage to Adams Cottage than the other 25+ tress alongside them, which are less tall. These trees also restrict light throughout year due to high canopy (20m+). See North bearing on plan diagram for typical wind direction towards Adams Cottage.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
