This application relates to 3 mature Lime trees which were subject to approved height reduction work approximately 5 years ago. Since that work there has been considerable re growth and occasional instances of lower branches dropping due to natural die back on trees 2 & 3. There are branches on these trees that overhang the garage roof and their removal as part of the reduction would minimise the possibility of future damage.

This application seeks permission for further work to reduce the trees to a more uniform and manageable height.
