G1.2 - Group of approx. 9 mature Yew trees growing over delivery track - prune to clear wall and building by approx. 500mm to prevent structural damage.

G2.2 - Group of 4 mature Yew trees - prune to clear building by approx. 500mm to help prevent structural damage to roof.

T1.3 - 1x Large mature Oak tree adjacent to last Yew tree leaning towards building - prune to clear building by approx. 1 metre. Remove major deadwood over track.

T1.4 - 1x Large mature Oak near gate - prune to reduce primary branch growing towards building by approx. 1.5 metres.
