Tree A - Rowan tree - full removal. As seen on attached pictures this tree has disease damage to all main branches and the trunk. Concerns over the safety of the tree in relation to ourselves, our vehicles that park in close proximity and members of public as the branches over hang the pavement and numerous pedestrians use that path due to access to other houses on the street as well as students attending the Brunts Academy. I also have concerns over the proximity of the tree to the wall and gate pillars as they form an integral part of the house and street in terms of the conservation area and feel that through either root growth or falling branches these could be damaged.

Tree B - Believed to be a Leylandii - full removal. We have lived at the property for 9 years and this tree was there when we moved in, it is continuing to grow rapidly and again is in close proximity to the boundary garden walls. Under that tree drainage pipes for the rainwater from both properties also runs. There is already evidence of root damage to the walls and pavements as shown on the attached pictures. I would like to remove this tree as I am concerned about the damage to the walls, drainage and pavement as it continues to grow and also feel it does not add to the character of the houses or street and will continue to grow rapidly over the coming years and detract from the street in terms of the conservation area.
