Replacement of first floor flat roof terrace balustrade design with frameless clear glass, fixed to the outer face of the roof so that the base frame is totally hidden from view when on the terrace or inside the house.

Approval was for solid half-height walls around the terrace perimeter, with exterior sloping slate covered roof-style edge mimicking the existing roof, but presenting the occupants with a solid barrier from the terrace and inside the house.
