Proposed plan is to raise the ridge height 500mm and create a full length Dormer to the rear. This will be for 2 new bedrooms and a bathroom. On the 1st floor the rear of the garage will be used to create a new en-suite and wardrobe area for the main bedroom, the second bedroom will have doors with a glass Juliet balcony to replace the window. The ground floor layout will change with the stairs reversing position to provide for a more open plan living area. Large Bi-fold doors to the dining area at the rear while a glazed box window seat will be added nearer the kitchen. A small porch to the front entrance will be created with a pitch roof , this will be clad in a composite wooden style cladding and will be also added to both gable ends, the dormer and above the existing garage.
