Replacement trees (4) to be planted in the tree line. 1no. Hornbeam, 1no. Beech, 1 no. Oak, 1 no. Field Maple. Stock size to be c3m height with 8 to 12cm girth at 1m, containerised or root-balled or bare root.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - o showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
