Please identify the tree(s) and provide a full and clear specification of the works you want to carry out
As shown in red on the attached plan, tree number T19 from TPO 172 is to be removed. It has significantly supressed growth and limited reduction in amenity because of the more dominant tree on its south side.
Following removal of this T19, its replacement with a Dawyck's Beech is proposed. This will be planted within 2 metres of the position shown by the green 'New tree' icon on the attached plan, and no further than 2 metres from the boundary hedge to the east.  The tree will be planted at nursery 'Standard' size. If available at the time of planting, it will be the purple-leaved variety.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).
