I am the property manager for this site. There are two garage entrances on site which require shutter doors to enhance security. There have been doors installed previously but they did not meet current regulations, therefore, the existing doors have been terminated so they cannot be used but have remained in situ in the open position. We are now seeking permission/consent for new doors to be installed, the doors will be used by the residents of the block of flats. The provided quotes and specs are based on comments from a chartered surveyor for appropriate ventilation. The surveyors comments are as follows:

"Natural ventilation should be provided by permanent openings at each level with a venting area of at least 1/20th of the floor area at that level of which at least half should be provided between two opposing walls.

Looking at the garage doors, a 3 x 2.1 perforated door will provide. A possible ventilation of 4.55 square meters, which will be more than required considering the existing ventilation on the opposite walls. "
