- T1 Grisilenia Reduce back into a hedge, height 6 feet from the ground.
- T2 Eucalyptus Crown lift to 6 meters from the ground.
- T3 Lawson Cypress Crown lift to 6 meters from the ground.
- T4 Holm Oak Remove to ground level and poison, self set, growing up into the feature pine trees above.
- T5 Pine Remove major deadwood.
- T6 Oak Remove/ reduce major deadwood and crown thin 20% to allow more light into the garden below.
- T7 Oak Remove/ reduce major deadwood.
- T8 Ash Ash dieback disease, remove to ground level.
