In response to a previous application submitted (Application no. 23/02802/VC), Bristol City Council placed a tree preservation order on a white poplar in our front garden (TPO 1477; T1 on tree location plan). We objected to this decision and recently received a letter from the Council (their ref: GD02.84 - 162725, letter dated 29 January 2024) saying 'the Council decided not to confirm the Order'. We have been advised by Debra Moreton and Jacob Stringer of Bristol City Council to submit a new application to have the tree removed.

Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1: To remove Poplar. Saplings are spouting up from the root system across the front lawn towards house and there are already signs of movement in the driveway (largest sapling is 6.8 metres away from the base of the tree and 1.2 metres in height). The tree's branches are interfering with overhead cables. The tree is already too big for the space it is in, and is thought to be only 8-10 years old. Poplars have an extensive root system that can damage house foundations. The foundations to our house are likely to be shallow, as the house dates from about 1860. The RICS level 3 home survey we commissioned before buying the house in June 2023 stated that "it would be sensible to remove the tree as in due course it could influence ground

conditions under the foundations and cause subsidence". We recognise the amenity value of trees in urban areas and the distinct character of the Cotham and Redland conservation area and plan to replace the tree with a tree more suitable to its surroundings.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
