Description of works:

The 7 referenced oak trees along the west boundary of The Coach House (carrying TPOs Reference: 98/00818/TPO: Tree numbers T7, T8, T9,T10, T11, T12, T13) have grown to the extent that they are significantly overhanging Chestnut House touching the property in places and causing significant shading.

To ensure that the trees do not cause damage and maintenance issues it is necessary to prune them back to the boundary line of Chestnut House .

Following advice it is proposed that this can be achieved by raising the crowns on the western side of the trees to 5m and trimming the end of higher branches in line with the boundary fence of Chestnut House. Please note it is only proposed to carry out the works on the western side of the tree.

The crown being raised to 5M on the western side is similar to its existing height on the eastern side, the trees will therefore remain balanced in appearance. The trimming of the the ends of the higher branches that overhang Chestnut House are also to the western side of the tree crown and beneath the crown top of the trees. The access drive for the house "Cedars" runs between the boundaries of Chestnut House and The Coach House and therefore the majority of the tree width will be retained. The trimming of the higher branches to the boundary fence represents approximately 3m of an overall branch length of 11m

The referenced trees are over 20m in height . The trunks of the Trees are approximately 8m from the brick wall of Chestnut House.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
