Appendix 2: Woolley Firs Tree Safety report/schedule

Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

- T1 2 ash trees infected with ash dieback disease overhanging neighbouring property with 25-50% crown dieback Fell or reduce to a safe height.
- G14 15 ash trees infected with ash dieback disease with 0-25% crown dieback, adjacent to paths used by pupils, teachers and staff visiting for educational activities. Fell or reduce to a safe height.
- G15 10 ash trees infected with ash dieback disease with 25-50% crown dieback, adjacent to paths used by pupils, teachers and staff visiting for educational activities. Fell or reduce to a safe height.

Where ash trees have to be felled, rather than reduced to a safe height we will plant pedunculate oak and or/protect any suitable saplings (including any 'resistant' ash) with tree guards.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o sketch in buildings, including adjoining properties
 - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - $\circ~$ marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
