I have been asked to apply for the following tree removals :

Trees located - Front boundary of property

- T1 Chestnut
- T2 Oak
- T3 Chestnut
- T4 Chestnut

The reason for the submission of this application, is that the home owner would like to erect security fencing and electric gates to ensure cars and property are well protected.

The trees/stumps and roots are in the desired security line.

The customers are not opposed to replanting with younger specimens somewhere else on site to replace, should that be required.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
